Fiscal year 2006-07 was truly historic for CAAHEP. We embarked upon two major projects—an online Site Visitor learning tool and our first-ever Federal contract on Emergency Preparedness.

The year began with an invitation from the Health Resources and Services Administration (HRSA) to submit a proposal for a contract to work on adding emergency preparedness to the educational Standards and Guidelines of the fields in which we accredit. At their July meeting, the CAAHEP Board discussed the pros and cons of such a project and decided it was an important topic and very much consistent with our vision and mission.

As for the Site Visitor training tool — this is something that had been talked about for the past several years and we are delighted to say it is now reality! If you haven't taken the "quiz" — I urge you to go to [www.caahep.org](http://www.caahep.org) and click on the icon to work your way through this wonderful tool.

Of course, even as we were working on these two major initiatives, the business of accreditation went on. The Board of Directors voted on a total of 489 recommendations from our Committees on Accreditation.

At our 2007 Annual Meeting we acknowledged the contributions of long-time Commissioner, Dr. Stanton Nolan. Stan was the well-deserving recipient of our 2007 Award for Exceptional Service.

CAAHEP continues to be financially sound. We have settled into our headquarters building in Clearwater, Florida, and are saving a considerable amount of money by owning rather than renting.

I am honored to have served as CAAHEP president for the past two years and feel confident that the new president, Bill Horgan, will lead us on to even bigger and better things! I appreciate all of the work that the committee members did and continue to do to advance the accreditation process and be responsive to the CoAs. I would also like to thank Kathy, Cynthia and Lori for all of their support, in making the job of the CAAHEP president just a little bit easier.





**Treasurer's Report**  
**Dan Points**



For the first time, Lovett & Company P. A., conducted an independent audit of the Commission on Accreditation of Allied Health Education Programs. CAAHEP continues to exhibit growth and stability by increasing overall net revenue. FY 2006-2007 reflects a net increase of \$238,280. This is largely due to funding provided through a contract with the Health Resources and Services Administration (HRSA). Special projects expenditures were primarily responsible for an increase in overall expenditures, again associated with the HRSA contract as well as preparation of the site visitor training quiz and annual reporting tool.

## Accreditation Actions: July 2006 – June 2007

A few highlights for the fiscal year just ending,

- The CAAHEP Board of Directors reviewed and acted upon 489 accreditation recommendations from 16 Committees on Accreditation.
- Medical Assisting forwarded the largest number of recommendations for both initial accreditation (36) and continuing accreditation (89).
- One hundred ninety six (196) more programs received continuing accreditation than initial accreditation.
- CAAHEP awarded accreditation to programs in Exercise Physiology and Polysomnography for the first time this year.

### INITIAL EXPIRATIONS JULY 2006-JUNE 2007

**Programs that are in an initial accreditation status can either be moved to a continuing status of accreditation, be placed on probation or have their initial accreditation status expire. When an initial status expires, the program is no longer CAAHEP accredited.**

*No CAAHEP accredited programs were allowed to expire during this fiscal year. This is the first time in two years that no programs in an initial status of accreditation have been allowed to expire.*

## Total Number of Accredited Programs and their Accreditation Status (June 30, 2007)

At the end of fiscal year 2006-2007, CAAHEP had 1,927 accredited programs. Of the 19 program areas in which CAAHEP accredits, only our newest area, Personal Fitness Trainer, does not yet have any accredited programs.

Additionally, as the fiscal year came to a close, CAAHEP had 404 programs with initial accreditation, 1,480 with continuing, 30 programs with probationary accreditation and 13 programs that are currently inactive.

Of the programs that currently have initial accreditation, 132 (33%) received accreditation this fiscal year. Of those programs that currently hold continuing accreditation, 328 (22%) received accreditation this fiscal year. Additionally, of the 30 programs that currently have probationary accreditation, 23 (77%) were voted on during this fiscal year.

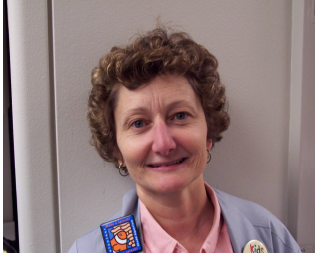
**POC Accomplishments 2006-2007**

The Performance Oversight Committee (POC) oversaw a number of technological advances for CAAHEP this year. They include:

- A complete redesign and launch of the CAAHEP website. The new site features areas specifically designated for Program Directors and Students, a Hot Topics News Area, and a more highly defined search function for CAAHEP accredited programs.
- The development and launch of the CAAHEP Accreditation Services Hub. This is a "members only" area of the CAAHEP website where announcements on specific topics can be posted and internal CAAHEP documents stored.
- The development of a new database for CAAHEP. This database of all CAAHEP-accredited programs and their sponsoring institutions will give us better information for the website and a greater ability to communicate more effectively with our accredited programs.

Additionally the POC continues to:

- Collect and compile data. This data includes an Accreditation Process Assessment for Programs, the CAAHEP Liaison Evaluation, Meeting Evaluations, the Committee on Accreditation Activity Report (CAAR) and the Spring CoA Survey.
- Review and revise all forms to collect data and all survey instruments.



## Planning and Development Committee

The fiscal year that began July 1, 2006 was one of the busiest in CAAHEP's history thanks, in large part, to the leadership and work of the Planning and Development Committee.


The Planning and Development Committee gathered bids for upcoming meeting sites and they agreed upon Denver, Colorado, for the July 2008 Workshop for the Committees on Accreditation. They continued to explore options for the 2009 Annual Meeting of the Commission.

The Committee oversaw the design of a new online annual reporting tool for participating Committees on Accreditation. But most significantly, they began the year by approving a special project to produce an online learning tool for site visitor training. The result of that project was finalized at the end of the fiscal year and is now available on the CAAHEP website.

## ***Why Emergency Preparedness?***

What does emergency preparedness have to do with accreditation? Why is it of concern to CAAHEP?

The answer is that like all major issues on CAAHEP's agenda, the leadership of CAAHEP (represented by the Board of Directors) determined that an effort to add emergency preparedness to CAAHEP's accreditation standards would be a critically important first step in helping to assure the nation that our health workforce is prepared to deal with disasters of all kinds.

Our Board was asked to consider emergency preparedness and the education of the health workforce, in the summer of 2006, when we were invited (along with several other accrediting bodies) to respond to a Request for Proposals by the Health Resources and Services Administration (HRSA). HRSA believed -- and the CAAHEP Board agreed -- that this national priority of preparation for disaster, whether man-made (as in terrorism) or natural (as in hurricanes, floods, epidemics) should be part of the pre-service education of health professionals. We further agreed that the mechanism of accreditation was an appropriate tool for catalyzing health educators to accept this challenge. [HRSA's RFP also was successfully responded to by the Council for Accreditation of Counseling and Related Educational Programs].

As part of the effort to educate our communities of interest about this important new initiative, CAAHEP hosted a meeting (January 2007) of the CAAHEP Board of Directors and the Chairs of our Committees on Accreditation (CoA) where attendees were "wowed" by keynote speaker Dr. Ralph Shealy. Dr. Shealy's PowerPoint presentation lays out powerfully the argument that health care workers have an obligation to use their education and skills in a disaster environment. Dr. Shealy was such a big hit in January, several attendees urged us to invite him back to keynote our April meeting of the Commission.

Unfortunately Dr. Shealy was unavailable in April, so he sent a DVD instead. As our first-ever "virtual keynote speaker" he was once again a big hit! We have subsequently distributed many copies of that DVD to interested program directors and others.

A lot of effort in 2006-07 was spent educating our Committees on Accreditation and moving them in the direction of adding emergency preparedness language to each set of CAAHEP Standards and Guidelines. As we go to press, the project is ongoing. Next year's Annual Report will contain a progress report of these important activities.

# Progress on Becoming an Outcomes-Based Accreditation System



In October 2000, the CAAHEP Board of Directors adopted the *Standards and Guidelines for an Accredited Educational Program in Surgical Technology*. While the approval of **Standards and Guidelines** is a common task for the CAAHEP Board of Directors, this time it was not routine. This was the first set of **Standards** to be approved using what was at that time the newly adopted Outcomes Based Standards Template.


By the time the Board took that vote in October 2000, it already felt to most Board members as if we had been talking about outcomes forever! And so it was no surprise when, at their January 2001 meeting, the Board approved a motion calling for all of the CAAHEP **Standards** to be revised and reformatted into that outcomes-based template no later than 2007.

So, as we review the 2006-07 year, where are we on that ambitious move by the CAAHEP Board of Directors? With only one exception (Surgical Assisting — and they are in the process of revision), all CAAHEP **Standards** are now in the outcomes-based format. In fact, some have been in that new format long enough to have gone through a second round of revisions. And the template, itself, also went through a second round of revisions.

But of course, putting the Standards into an outcomes-based template and truly becoming an outcomes-based system are not exactly the same thing! Our Committees on Accreditation have struggled with what tools to use for outcomes assessment and what thresholds to set for establishing success. CAAHEP has hosted at least two Summer Workshops that focused on these issues and much was learned from the sharing of what has worked (and not!) for various Committees.

The CAAHEP Board of Directors remains committed to helping our Committees on Accreditation become truly outcomes-based in their approach to reviewing programs. That does not mean that all “inputs” will disappear. Especially when it comes to initial reviews, process-oriented measures will always remain an important part of accreditation.

But CAAHEP is proud to remain in the vanguard of the outcomes-based approach to accreditation.

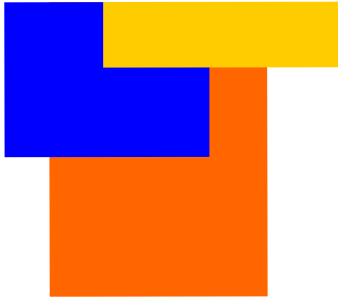
